GENERAL RULES NOT RESPONSIBLE FOR ACCIDENTS



1. The Perry County Fair Association through its executive committee reserves the right to interpret its own rules and determine all matters and differences pertaining to the county fair and livestock show.
2. Exhibitors must be a resident of Perry County or an active member of a Perry County 4H, FFA, or EHC club. Juniors must be members of a Perry County 4H club or FFA chapter to be able to participate in the premium sale. Membership status will be checked.
3. An entry from an adjoining county may be displayed, but is not eligible for premium unless the owner is a member of an organization in Perry County and has not received premium from another county.
4. Each exhibitor will receive ONE exhibitor number. There will not be separate numbers for livestock and the exhibit hall. Every entry must be registered with the proper superintendent(s) and listed in the entry book. Livestock exhibitor numbers will be given at livestock check-in and entry fees will be paid at the time of registration of poultry and livestock.
5. Premiums will be paid only on items listed in this catalog.
6. Decision of judges in awarding premiums will be final.
7. Premiums will be paid on point basis, with disbursements made at the discretion of the executive committee and checks issued following the fair in September. Premium sale checks will be completed as soon as all buyers have paid. Perry County Youth Livestock Foundation is responsible for the Robert Parish Memorial Premium Sale checks.
8. Premium checks will be mailed (no exceptions). To ensure proper delivery, give a proper mailing address when registering.
9. Premium checks not cashed within 90 days will be voided.
10. If no competition is present in a class, the judges may award first, second, or third place to any entry.
11. Precautions will be exercised in caring for livestock, but the Perry County Fair Association nor any of its members, any cooperating agency nor individual, will not be held responsible for ANY accident or damage that might occur to the livestock while en route or on display at the fairgrounds.
12. No claim for injury to any person or property shall ever be asserted or suit instituted or maintained against the Perry County Fair Association, its officials or their agents on behalf of any person, firm, cooperating representative, servant, or employee having license or privilege to exhibit at said Perry County Fair and Livestock Show.
13. If the exhibitor does not have a driver's license, their name and the parents name will be on the premium check. Any exhibitor under the age of 18 must have a parent's printed name as well as their own listed on their registration paperwork.
14. No alcohol will be allowed in the barns.
15. No dogs in the barn.
16. There will be no tolerance of the selling of animals in the barn.
17. All questions in dispute not covered by the rules of this catalog will be referred to the Perry County Fair Association Board of Directors, whose decision will be final.

Entry fee is \$25 and \$5 optional photogenic.

Competition is evening gown, outfit of choice, and photogenic. Competition for Teen Miss and Miss will also include interview.

Pictures may be any size, color or black and white, glitz or natural. Please bring photos to check-in in a plastic protective sleeve or zip lock bag. **DO NOT BRING PHOTOS IN FRAMES OR CELL PHONES.** Label photo with the child's name and age on the back.

Each contestant age 13 and up must be a resident of or attend an academic school in Perry County. Boy's pageants 0-4 and girl's pageants 0-13 are open. All female contestants must have been born female, males born males. Females cannot be, or at any time have been married, pregnant, or have had a child. A contestant must not have ever been convicted of any crime or have any criminal charges pending.

Teen Miss and Ms Queens will compete at the Arkansas State Fair.

The Miss Fair Queen will receive a \$1,000 scholarship and the 1st Alternate will receive a \$500 scholarship from the University of Arkansas Community College in Morrilton.

ATTIRE: formal wear, flower girls style dress, prom dress or Sunday best. Dresses may have embellishments. **IN NO WAY** does the cost of the contestant's attire have a bearing on the outcome of the pageant. **DRESSES WILL NOT BE JUDGED**

Ages 9 and under - NO pageant dresses, cupcake dresses, or dresses with tutus - no glitz wear. No false enhancements are allowed for age divisions 0-9 (flippers, fake hair, fake eyelashes, fake nails, spray tans, etc.)

Contestants, parents and/or supporters are not to approach the judges at any time. Their decision will be final.

There is a dressing room available. This is a very small area so only one person will be allowed in the dressing room with each contestant. If the room becomes too crowded, those people not contestants, will be asked to leave the dressing room.

ANY display of poor sportsmanship and/or unbecoming conduct, any interference and/or disturbance, or any other behavioral problem created by a contestant, traveling companion, parent, relative, or even a supporter of a contestant could result in disqualification of the contestant. There will be no refunds. Contestants, parents and/or supporters are not to approach the judges at any time. Their decisions will be final. All judges will come from out of the county.

The Perry County Fair Board is not responsible for any lost, stolen, or damaged property. Please treat the facility with the utmost respect and clean up after yourself when the event is over.

Contestants in the Perry County Fair Youth Talent Show will compete in the appropriate age division. Divisions are based on age by opening day of the Arkansas State Fair. Contestants age 13 and over are not allowed to compete in both talent and pageants as the pageant winners must compete at the state fair. In the event a contestant's parents are divorced and live in separate counties, and have been court ordered to reside jointly with both parents, the contestant can only compete in one of the two counties in which the contestant's parents reside. County winners must compete at the state fair and runner-ups must compete at the district competition, if the fair dates of the district fair are not the same as the county fair dates.

Divisions:

Kids – Ages 5-9

Youth – Ages 10-13

Junior – Ages 14-17

Senior – Ages 18-23

Contestants must be a resident of Perry County for 6 months immediately preceding the county contest or must be a full-time student who has attended school (academic, not dance, etc.) in Perry County for one full semester immediately preceding contest. Contestant must not have a criminal record.

Junior and senior division winners will compete at the Arkansas State Fair. If they win at the Arkansas State Fair, they will not be eligible to compete at the Perry County Fair and Arkansas State Fair the following year. They will be eligible to compete the second year after winning the Arkansas State Fair.

Runner-ups are eligible to compete at the district fair.

No contestant will be allowed to compete in more than two categories. Any props must be used as a functional part of the contest act. The fair does not provide music, instruments, or props.

Any inappropriate lyrics of a song in the vocal and variety categories or inappropriate moves in the dance and variety categories will result in immediate disqualification. The contest director has the right to interrupt a performance if it is not deemed suitable for the talent show.

Any act must not exceed the 3 minute time limit (including recorded introduction). CD accompaniment is also subject to the same 3 minute time limit. All acts are limited to a 1 – minute time limit to set up equipment.

There will be an Overall Winner of the Youth Talent Show who will receive a \$50.00 cash prize. There will be an Overall Second Place Winner who will receive a \$25.00 cash prize and an Overall Third Place Winner who will receive a \$10.00 cash prize.

Divisional winners will receive a trophy.

There are 6 categories of competition.

Vocal Solo shall consist only of a vocal performance by one vocalist. No other talent may be performed in conjunction with the vocal solo. CD's for accompaniment will be allowed.

Vocal Group shall consist of two or no more than fifteen vocalists. No other talent may be performed. CD's for accompaniment will be allowed.

Instrumental Solo shall consist of an instrumental performance without vocal utterance by one performer. Taped accompaniment may be used. The fair does not provide key boards. NO DRUMS

Dance Solo shall consist of one dancer. No other talent may be displayed with the dance performance. Tap, jazz, ballet, folk, ethnic, fad, etc. will be judged in this category. A routine can include two gymnastic or acrobatic stunts.

Dance Group shall consist of two or no more than fifteen dancers. No other talent may be displayed with the dance performance. Same rules as listed under Dance Solo apply.

Variety shall consist of a performance of one or no more than fifteen people. Acts that qualify for variety: song and dance, vocal and live instrumental, lip sync, pantomimes, impersonations, skits, juggling, ventriloquism, and magic. NO DRUMS and NO BATONS

GENERAL RULES NOT RESPONSIBLE FOR ACCIDENTS

1. All exhibits must be pre-registered. The deadline to preregister is August 21, 2026.
2. There will be two opportunities, Sunday, August 16 from 1:00-3:00 pm and Friday, August 21, from 9:00-11:00 am, for participants to come to the fairgrounds to receive help with the preregistration process. Further details will be provided on the Perry County Fair Association Facebook page.
3. Exhibits can be dropped off at the following times: Thursday, September 10 from 4:00-8:00pm and Friday, September 11 from 9:00am-12:00pm.
4. Exhibits will stay on display and cannot be removed until Friday, September 18. Release times will be posted. Early removal of exhibits will forfeit premium money and ribbons.
5. Every attempt to contact the owner of any exhibit left in the building after this time will be made. If the item is not picked up within two weeks, all items will be disposed of.
6. All items must be made by the exhibitor in the past **TWELVE** months.
7. Exhibitors must be residents of Perry County or belong to an organization (4H, EHC, or FFA).
8. No exhibitor will be allowed to interfere in any way with the judges(s) in the performance of his/her duties.
9. Every article will be under the control of the superintendent(s) and every possible care will be taken to prevent damage, but in no case will the Perry County Fair Association be responsible for any loss or damage that might occur.
10. Articles will be judged and awarded points according to their merit.
11. No exhibitor will be awarded more than one premium in any class (only **ONE** entry for each category is acceptable in any division and must be the sole property of the exhibitor).
12. Please see individual divisions for division rules and regulations.
13. If a class has had no entries for two consecutive years, the fair board reserves the right to delete it for the following year.

DEPARTMENT – EDUCATIONAL BOOTHS

ADULT DIVISION 101

YOUTH DIVISION 201

1. The superintendent and the judge will determine whether a booth is in the educational, exhibit, or commercial division.
2. An educational booth should conform to the score card printed below. The educational booths will receive **A, B, or C** rating. **A** booth will receive 50 points; **B** booths will receive 40 points; and **C** booths will receive 30 points. Best of Show will be awarded to both Junior and EHC division.
3. An exhibit booth is an unmanned booth that simply displays an article or articles and one that does not follow the criteria of the official score card for educational booths. Acceptance of exhibit booths will be limited by availability of booth space not already assigned to organizations and clubs. Exhibit booths will not be rated and will not receive premium money.
4. A commercial booth is one by a business or individual with the purpose of promoting their products(s). These booths will not be judged and will not receive premium money.
5. All requests for booths in the exhibit building must be made to Whitney Wright. Please report the subject or title in order to avoid any duplication.
6. NO raffles are to be sold without permission of the Perry County Fair Association.

DEPARTMENT II HOME ECONOMICS RULES AND REGULATIONS

1. All foods must be canned by the exhibitor within the **PAST TWELVE (12) MONTHS**.
2. Exhibitors must be residents of Perry County or belong to an organization (4H, EHC club, or FFA).
3. No exhibitor will be allowed to interfere in any way with the judges(s) in the performance of his/her duties.
4. Every article will be under the control of the superintendent(s) and every possible care will be taken to prevent damage, but in no case will the Perry County Fair Association be responsible for any loss or damage that might occur.
5. Articles will be judged and awarded points according to their merit.
6. No exhibitor will be awarded more than one premium in any class (only **ONE** entry for each category is acceptable in any division and must be the sole property of the exhibitor).
7. All containers or articles must be labeled by the exhibitor with entry name, address and exhibitor number. Label is to be placed ¼ inch from the bottom on the opposite side from the jar's manufacturer label.
8. Containers for fruit and vegetables must be **standard** quart or pint jars, and bands should be left on jars. Jelly, jams, preserves, conserves and marmalades may use one-half pint jars or jelly jars.
9. NO paraffin should be placed on jellies, preserves, marmalades, conserves, or jams. It should be sealed with a lid.
10. The exhibits will be judged by an **A, B, and C** rating. **A** and **B** places will receive premiums paid on the point basis.
11. A youth division is available to all boys and girls, unmarried and attending elementary or high school, for all classes. Ages 5 to 18 for handicrafts, baked foods, home furnishings, clothing, and dried fruits and vegetables and for all classes of canned food preservation. (**ALL JARS MUST BE LABELED AND AGE INCLUDED.**) Adult division is open to anyone over age 19 (unless otherwise stated in the department).

POINTS THAT WILL BE CONSIDERED IN JUDGING

CONTAINERS – Standard jars, clean and polished lids and rings free from rust or spots. Leave band on lid.

PACK – Jars filled to appropriate headspace. Good proportion of liquids and solids. All products covered with liquids.

UNIFORMITY – Pieces of same size and shape. Natural, even color throughout.

TEXTURE – Products free from defects. Shows careful selection of products.

APPEARANCE – No loose seeds, spices, strings, etc. (EXCEPT WHERE STATED IN CATALOG).

REGULATIONS

FRUITS

Fruits should be firmly packed with uniform size, shape and color. One-half inch headspace. Shingle for peaches, pears and apple halves. Liquid or syrup should cover fruit.

TOMATOES

Tomatoes should have one inch of headspace. Liquid on tomatoes should be natural juice from tomatoes with a minimum number of seeds. **ABSOLUTELY NO WHOLE TOMATOES.**

REGULATIONS

VEGETABLES

One inch headspace (except for starchy products like corn, shelled beans, or peas, which need one and one-fourth inch headspace). Greens and starchy vegetables should have enough liquid to make a loose pack when processed. (Put vegetables up to one and one-quarter, then the rest liquid to make a loose pack).

MEATS

Jar full (except for one to one and one-quarter inch headspace). Good proportion of meat and liquid with excess fat and gristle removed; same size and shape. Only one kind of meat to a container. Liquid should be clear; there should not be over one-half inch of fat on chicken or beef, nor over three-quarters inch on pork.

PRESERVES, JAMS, JELLIES, CONSERVES & MARMALADES

REGULATIONS

PRESERVES

Ripe, whole berries, or small fruit, or slices of large fruit, translucent and syrup consistency of honey. (Some small fruits such as grapes, cherries and plums are halved to removed pits or seeds.

JAMS

Jam is usually less firm than jelly with fruit crushed uniformly; not too runny; not too stiff; but a definite pull on jar when turned on side.

JELLIES

One-quarter inch headspace. Clearness and color. Free from sediment, pulp and crystals. Consistency firm; not sticky, syrupy, or gummy.
NO PARAFFIN ON TOP.

CONSERVES

Jam-like products made from a combination of two or more fruits usually combined with raisins or nuts. Fruits are small pieces, evenly distributed throughout the tender, jelly-like mass. Little to no “free” syrup; if there is any syrup, it should be heavy.

MARMALADES

Made from a single fruit or a combination of fruits and usually includes citrus fruit. Small uniform pieces of fruit (and finely chopped citrus peel) evenly distributed throughout a clear, jelly-like base. Clear and translucent with NO FREE SYRUP.

DEPARTMENT VI – LIVESTOCK LIVESTOCK RULES AND REGULATIONS

HEALTH RULES AND REGULATIONS

1. All animals entering the grounds, including those for display only, **must** meet the requirements for their particular species and will be inspected by the superintendent or his representative.
2. Any animal showing evidence of infections or contagious disease, or of external parasitism, and animals with active ringworm lesions (with the resulting loss of hair), multiple warts easily visible with close examination, or atrophic rhinitis, **WILL NOT** be permitted to exhibit, and will be sent home immediately. Superintendent has the right to disqualify any animal that does not meet health standards.
3. Livestock (except for sheep, goats, horses, and steers) **must be accompanied by a certificate of veterinary inspection issued within 90 days prior to exhibition.** “Certificate of Veterinary Inspection” refers to a legible record (made on an official form) by an accredited veterinarian.
4. All cattle and pigs are required to have an 840 RFID tag per state rules.
5. The following are health requirements broken down by species:

FOR CATTLE

1. All heifers that are 4 to 12 months of age shall be vaccinated before entering show.
2. Females over 12 months of age must be calf hood vaccinated or from a Certified Brucellosis Free Herd. Exhibitor must provide certificate.
3. Steers shall be subject to a health inspection on exhibition grounds and must have proof of baby teeth.
4. Although not required at the county level, the board would like to make it known that if an exhibitor plans to take a steer to district fair, it will require a healed tattoo.

SWINE

1. All swine must have an official premise identification.
2. Animals 6 months old or older to be tested negative for Brucellosis within 90 days prior to the exhibition or originate directly out of a validated herd, with validation number and date of last herd test shown on certificate. (Barrows are exempt).
3. Animals to be tested negative for Pseudorabies within 90 days prior to the exhibition on a test approved by the State Veterinarian or originate directly out of a Qualified Pseudo rabies Free Herd.
4. Free of other contagious, infectious, and communicable diseases (erysipelas, atrophic rhinitis, etc.); otherwise they will not be allowed to show and will be released from the fairgrounds.

SHEEP

1. Sheep will be inspected on fairgrounds.
2. Absolutely no sheep showing sign or symptoms of disease particularly ring worm, foot rot, sore mouth, sheep pox, or scrapie, will be allowed to show.
3. Any sheep not tattooed must have a scrapie tag.

GOATS

1. Goats will be examined on grounds by fair personnel, veterinarians, or state-federal personnel.
2. No goats showing evidence of abscesses and certainly draining abscesses will be allowed to show and may be released from the fairgrounds.
3. Goats showing evidence of any other disease may also be released.
4. Any goat not tattooed must have a scrapie tag.

ARKANSAS RABBITS

1. Rabbits will be inspected on grounds.
2. No rabbits showing symptoms of disease will be allowed to show.
3. No rabbits under 6 weeks of age allowed.
4. All rabbits should have an identifying tattoo in their left ear.

ARKANSAS HORSES

1. Negative EIA test required within the past 12 months for all animals over 6 months of age.
2. Nursing foals under 6 months of age are exempt from testing if accompanied by negative tested dams.
3. Photocopies of the test papers will not be accepted; carbon copies are acceptable.

ARKANSAS POULTRY

1. Pullorum-Typhoid: All poultry, including domesticated game birds, quail, pheasants, pea fowl, guineas, turkeys, and water fowl shall have had a negative Pullorum-Typhoid test within 90 days of the fair.
2. All poultry chain will be tested. There will be NO exemptions.
3. Any poultry showing evidence of infectious or contagious disease or insect infestation (mites, body sores, etc.) will not be permitted to exhibit. A body check will be done before registering.
4. No poultry under 6 weeks of age allowed.

GENERAL RULES AND REGULATIONS

1. Animals **must** be pre-registered. If online registration is not an option, there will be a paper registration form. All deadline dates will be posted for exhibitors. There will be no late registration.
2. The Livestock Department is open to both youth and adults. Adults will register their animals in the adult division and youth will register their animals in the youth division.
3. All exhibitors age 5-19 must show animals without assistance.
4. There will be a four year old and under show in all species. Four and under shows will be at the top of the show for that respective species.
5. Exhibitors may need to show that they are able to control their animals prior to the show.
6. No animal classes will combine. There will be open and youth exhibitors.
7. Entries in the Youth livestock are open to boys and girls with primary residence in Perry County between ages of 5-19, or who are a member of a Perry County 4-H Club or FFA Chapter.
8. Each exhibitor will receive an exhibitor number and parking pass. These will be given to the exhibitor at check in when entry fees are paid. Entry fee payment and check-in will be at the arena in the livestock barn. Every participant entering any livestock will pay the following entry fees for open and/or junior division shows:

Poultry	\$3.00 single entry/pen OR \$5.00 trio entry/pen
Rabbits	\$3.00 single entry/pen OR \$5.00 trio entry/pen
Goats	\$5.00/entry
Sheep	\$5.00/entry
Swine	\$8.00/entry
Cattle	\$10.00/entry

Horses	\$10.00/entry

9. Money collected from these fees will be used to make improvements on the barns. Perry County Fair Association reserves the right to make any changes without notice, to any rule pertaining to the county fair and livestock show.
10. Youth entering any exhibit must meet the necessary age requirement by the opening day of the current year's fair. Exhibitors may exhibit in this show no later than the fall after graduating from high school.
11. Exhibitors will be expected to keep bedding and animals in a presentable condition at all times.
12. Cattle and calves are to be shown with halter, broke to lead, well-groomed and presented in the best possible manner.
13. Sheep, goats and swine exhibits should be trained for showing, well-groomed and presented in the best possible manner.
14. All livestock must have been owned by the exhibitor by the ownership deadline set forth by the Perry County Fair Association unless otherwise specified in the rules and regulations listed under department headings.
15. All registered animals **MUST** be registered in the **EXHIBITOR'S NAME** and registration papers must be provided.
16. An animal may be shown in one class plus showmanship with the exception of female market goats, lambs, and hogs which can also be entered in breeding classes.
17. Exhibitors will be expected to show their own animals during shows and premium sale unless they have more than one animal in a class, then another youth exhibitor, whether that be a senior (age 14-19), junior (age 9 -13), or peewee (age 5 – 8) should exhibit the animal. When there are extenuating circumstances that prevent the owner from showing the animal, no less than four members of the livestock committee will make the final decision as to whether or not the extenuating circumstances warrant someone else being able to show the animal.
18. Separate classes will be established for each breed. Registration papers should be available for inspection upon request of livestock superintendent. If there are less than three animals entered in a breed, breeds of similar origin may be combined for show purposes.
19. A night watchman will be on duty; therefore, bunking in the livestock barn will not be necessary, or permitted.
20. **All livestock must remain on exhibit until the posted time of release at which time all livestock will be expected to leave the fairgrounds.**
21. ALL bulls 6 months & older (on date of show) **MUST** be shown with a nose ring – temporary or permanent.
22. No clipping in any barn entry areas.
23. Fitting, Grooming, and Animal Care: The primary care of all junior livestock entries is to be performed **by the exhibitor** whose name appears on the entry form. The exhibitor must be present at all times during the fitting when assistance is being provided except such times as the exhibitor may be exhibiting livestock in another class
24. Poultry Chain exhibitors will show 1 chicken per 5 they receive and will show in pens of 3.
25. There will be a **MANDATORY** market animal weigh-in prior to the show. Exhibitors will weigh their animals in and then turn in weight cards. The time and date that weight cards will be due will be posted for all exhibitors to see. The exhibitor or the person they designate **MUST** be present at weigh-in. There will be **NO** weigh-ins after this. If there is a question in regards to the weight of an animal, the fair board reserves the right to have that animal reweighed.
26. During the market shows, animals may be weighed again. Their weight must be within a 5% margin of the weight recorded on their weight card.

27. Each exhibitor is responsible for his/her stall/pen. The stalls and pens for ALL livestock must be cleaned out at the conclusion of the fair. If the stalls or pens are not cleaned out when your animals are removed from the grounds, your premiums will be forfeited.
28. All animals are expected to remain on the grounds until released at the posted date and time. Exiting the fairgrounds prior to that date and time will result in premiums being forfeited.
- 29. On the day of the premium sale, any equipment may be packed up or stalls cleaned out until 11am. At 11am all activity must cease and may not resume until the conclusion of the premium sale. There will be an announcement made following the poultry auction when animals will be released. Any animals loaded and leaving before this time will forfeit premiums.**
30. Only exhibitors, animals, staff, judges, and judge's assistants will be allowed in the show ring during the show.
31. No sitting in the show ring area.
32. No feed or equipment will be allowed in the aisles that restricts the free movement of livestock and exhibitors.
33. Precautions will be exercised in caring for livestock, but neither the Perry County Fair Association nor any of its members, any cooperating agency nor individual, will not be held responsible for ANY accident or damage that might occur to the livestock while en route or on display at the fairgrounds.
34. Livestock owners are required to bring water containers, grain, feed and hay for their animals. All animals must be fed daily, or exhibitors will be asked to take animals home and forfeit premium money.
35. The Perry County Fair Association reserves the right to prohibit the exhibiting of any animal that is classed as unworthy or detrimental to public safety.
36. There will be no dogs allowed in the barns.
37. There will be no animal sales conducted in the barn. You may not put for sale signs on your animal cages or pens. You will be asked to remove them.
38. No alcohol will be allowed in the barn. If it is suspected you have alcohol, you will be asked to exit the barn and possibly the premises.

LIVESTOCK NOTICE

The Fair Board of any county, district, or the state reserves the right to have a blood and urine analysis done for any animal at their fair.

Any exhibitor administering a drug to an animal which would render the carcass unfit for human consumption or any exhibitor of an animal producing an analysis that can result in a quantitative or qualitative change in the characteristics of the animal will be required to return ALL premium money and could be banned from further competition. Their name and the lab analysis will be submitted to the USDA & FDA for further investigation and possible prosecution.

DISCLOSURE: Any animal receiving medication for any life-threatening disease or illness must be registered at the time they are entered in the fair.

1. Pee-Wees ages 5-8 will not compete against juniors and seniors in showmanship.
2. When there are not enough entries to have a category for showmanship in the junior division (9-13), it will be allowed for the junior member to compete in the senior division (14-19) if they choose to.
3. Senior members (14-19) may not compete in junior division (9-13); however, if there is only one in a senior competition, juniors who did not win the junior showmanship can show in the senior showmanship.
4. In order for a showmanship buckle to be awarded, there must be a minimum of 2 exhibitors.
5. At no time will a buckle be awarded when there is no competition.
6. Rules may be changed per the Perry County Youth Livestock Foundation Buckle Committee as the need arises.

AWARD FOR CARE OF LIVESTOCK QUARTERS AND MOST DECORATED

Awards will be given for the following awards: the exhibitor who keeps their livestock area the cleanest throughout the week and the exhibitor who decorates their stall area the best to coincide with the theme of the fair. Any youth livestock exhibitor, with any species, is eligible for this award and will be announced at the end of the week.

Adult Livestock Showmanship

1. Showmen must be 19 years or older, If there are a large number of exhibitors, there will be multiple divisions.
2. There can be divisions for all species.
3. Showmen are encouraged to dress according to the theme of the fair.
4. Entry fee: \$20.00

POSTERBOARD COMPETITION

1. The theme will be "Stars, Stripes, and Livestock".
2. Must be turned in by posted date at the appropriate area.
3. Awards will be given. Divisions and number of awards will be decided upon after all entries are submitted.
4. Name and age must be printed **on the back**.
5. Must include a title on the board.
6. No identifying photos of the exhibitor allowed. If there are any identifying photos, the exhibitor will be disqualified immediately.
7. Must be on one sheet of poster board or a tri-fold.
8. May use paint, colors, pencil, ink, photos, fabric, magazines, paper, etc. to tell your story.
9. Must tell one livestock project story per board.

10. Only one (1) entry per exhibitor in each division: rabbit, poultry, goats, sheep, swine, cattle, and horses.
11. Judging will be based on the creativity (eye appeal & attractiveness) of the poster; as well as, the informative portion (the facts that were stated and the educational portion – does the judge learn something from the poster?)

LIVESTOCK SKILLATHON

1. All youth exhibitors are eligible to participate.
2. There will be three age divisions:

3. This contest is closed to everyone except contestants, superintendents, and livestock personnel.

6. Awards will be given for first, second and third place in each division.

ROUND ROBIN SHOWMANSHIP

Round Robin Showmanship will be open to the top showmen, in both junior and senior categories, in the following species: cattle, swine, sheep, and goat. These showmen will compete by showing all species of livestock and the judge will pick an overall winner. The rules are as follows:

1. For safety reasons, representatives from the Perry County Fair Board will select the animals that will be shown in the Round Robin Showmanship, with each animal's owner and parent granting permission.
2. Coaching by an outsider will result in disqualification.
3. Showmanship dress code will be encouraged.
4. Contestants will be required to walk the different species around the ring and demonstrate control and set the animals up except for swine.
5. Scoring will be based on the following:
 - The showman's ability to properly show the animal.
 - The performance and control of the animal
 - The sportsmanship of the showman
 - The knowledge the showman has of the species
6. A 4H member may only enter in with one species. If the top showman is the same in more than one species, the reserve will take their place in one category.
7. There will be a rubric provided for the judges during this event.

RABBITS

REGULATIONS

1. All youth exhibitors are required to be present for the judging.
2. Any recognized breed or crossbreeds may be entered.
3. Only one entry per division, per breed.
4. Junior doe or buck is under 6 months of age.
5. Senior doe or buck is 6 months of age and older.
6. Rabbits will be judged according to ARBA standards.
7. A single fryer is defined as one rabbit not over 10 weeks of age weighing at least 3.5 pounds but no more than 5.5 pounds.
8. A meat pen is defined as three rabbits of the same color, preferably of the same breed but mixed breeds will be acceptable not over 10 weeks of age weighing at least 3.5 pounds but no more than 5.5 pounds. Animals may come from different litters, but the trio should look like triplets.
9. Meat pens and single fryers must have a TATTOO that is an individual rabbit ID number in the left ear.
10. Rabbits entered in the single fryer competition cannot be entered as a part of the meat pen trio. The only exception is when a meat pen entered has a mortality that would disqualify the entry. They may have one rabbit designated by the owner and signed by agent/advisor to be moved to a single fryer. Only one meat pen entry is eligible for this exception. This must be done two days before the show date.
11. Only market rabbits are eligible for the premium sale.
12. No rabbits can be put in cages until inspected by superintendents.

PERRY COUNTY YOUTH LIVESTOCK FOUNDATION LIVESTOCK SCRAMBLES RULES AND REGULATIONS

1. There will be two groupings of scrambles: a division for 4H/FFA members and a division for non-4H members. 4H and FFA members must be members in Perry County. The animals caught by non-4H members will not be retained by the contestant. They will instead be awarded a prize.
2. When a participant has their hands on an animal, no other participant shall be permitted to take hold of such animal or otherwise interfere. It will be at the discretion of the arena judge to decide who that livestock belongs to. All decisions made by the arena judges are final.
3. Scrambles are held in only one half of the arena.
4. 4H/FFA members are expected to listen to and act accordingly if the arena judges ask something of them.
5. Once a participant has caught a sheep or a pig, they forfeit the right to scramble for the other species. For example, if a junior catches a sheep, they cannot scramble for a pig during the same event.

CHICKEN

1. There will be the following age divisions for participants: (A) ages 5-8, (B) ages 9-13, (C) ages 14-19.
2. After the judges signal to begin, contestants will be allowed to catch and hold one chicken each.
3. Contestants will then bring the chicken to the judges.
4. Contestants keep the chickens they catch unless they are participating in the non-4H division.

PIG

1. There will be the following age divisions for participants: (A) ages 5-8, (B) ages 9-13, (C) ages 14-19.
2. Pigs will be turned loose at one end of the arena and contestants will remain behind a line at the other end until the signal to start has been announced by the judges.
3. The contestants must catch and hold the pig until declared the winner by the judges.
4. These pigs will not be taken home by the contestant. An age-appropriate market hog will be purchased for the contestant next spring to be shown at the county fair.

LAMB

1. There will be the following age divisions for participants: (A) ages 5-8, (B) ages 9-13, (C) ages 14-19.
2. Lambs will be turned loose at one end of the arena and contestants will remain behind a line at the other end until the signal to start has been announced by the judges.
3. The contestants must catch and hold the lamb until declared the winner by the judges.
4. These lambs will not be taken home by the contestant. An age-appropriate market lamb will be purchased for the contestant next spring to be shown at the county fair.

CALF

1. There will be two divisions: Junior: ages 9-13 years of age and Senior: ages 14-19 years of age.
2. The calves will be turned loose at one end of the arena while the contestants remain behind the line at the other end until the signal to start comes from the judges.
3. Contestants may use the rope provided by PCYLF during this scramble. The rope will have one pre-tied knot. **The rope must not be thrown or used as a lariat.**
4. The contestant must catch, halter, and hold the animal until the judges declare the winner.
5. The contestants who successfully catch the calves will be required to halter break and show the calves at the county fair the following year or reimburse the Perry County Youth Livestock Foundation **the market value of the calf.**

SCRAMBLE ANIMALS MUST BE REMOVED AT THE CONCLUSION OF SCRAMBLES

ROBERT PARISH MEMORIAL PREMIUM LIVESTOCK SALE

hosted and organized by
Perry County Youth Livestock Foundation

1. The sale is limited to one animal per exhibitor and that exhibitor must be an active member of 4H or FFA.
2. Premium sale is limited to the Grand Champion and Reserve Grand Champion in a single species unless the same exhibitor places grand or reserve in two different species. The exhibitor is then allowed to choose which animal to pull into the sale and the vacated spot will be filled according to the judging order.
3. Bids will be for premium only; no livestock will change hands.
4. Before the auction portion of the sale is completed, eligible exhibitors will participate in an add-on parade (large animals only)
5. Poultry Chain is not eligible for the premium sale.
6. The sale will consist of livestock in the following order: cattle, hogs, lambs, goats, broilers and fryers.
